### Oh, Canada...what's happened to our environmental laws?

Your support is needed to protect and improve Canadian legislation

Last year, the federal government passed an omnibus budget bill that dramatically weakened Canada's environmental laws. Over ten pieces of environmental legislation were modified or withdrawn, resulting in significant changes to federal environmental assessment laws, fisheries laws and the operation of the National Energy Board. In short, these changes weakened environmental protection in Canada.

The Environmental Law
Centre raised awareness of
these changes through many
articles, blog posts,
presentations, a webinar and
an interview on Alberta
Primetime. We also provided
the federal government with
our comments on changes to
federal environmental assessment laws.

With our recent publication of A Model Environmental and Sustainability Assessment Law, we hope to show how good environmental assessment laws can improve decision-making and protection in Canada.

While some changes have been fully applied, the federal government has not yet declared all the changes to fisheries law to be in effect. With your support, we can use this window of opportunity to reverse the suggested changes, and avoid a huge step backward for Canada's environment.

### Move over, mudboggers!

Donor dollars provide seed funding to tackle destructive off-highway vehicle use in natural areas

A flood of motorized users is testing the limits of the land and land managers. The public land laws that direct resource developments in Alberta do little to prevent access to old roads and cut lines. These areas attract unmanaged random camping, destructive off-roading and mudbogging. This abuse destroys waterways, disrupts wildlife and poses safety risks and user conflicts. Rural municipalities bear the burdens of ensuring safety and restoring damaged areas, rather than benefiting from planned recreational activities.

Environmental groups and responsible recreationalists agree on the need for better infrastructure, education and

enforcement, but these actions are not fully supported by current policies.

Thanks to a private donor who provided the seed funding to kick-start this project, we have researched and tested policy reform options through the Max Bell Public Policy Training Institute. This project recently received funding from the Calgary Foundation to engage user groups and key decision makers. Further support would let us address the role of the resource industries in managing access to abandoned roads. Many other environmental

groups have sought our help on tackling this complex issue.

Given the current flood reconstruction, regional plans, potential changes to parks legislation and proposals for a trails act occurring in Alberta, we are seizing the opportunity to gain traction on developing better policies and practices to manage off-highway vehicle use. Thanks to all of you for supporting work that will lead to new tools to protect Alberta's beautiful backcountry areas!
