2006 has been an exciting year at the Centre. Building on initiatives begun in previous years, the Centre completed an overhaul of its Governance policies and processes, and embarked upon a strategic planning process that will set the Centre's direction for the upcoming three to five years. The process of establishing new strategic objectives has been stimulating, with Directors and Staff engaging in a lively debate on what are the major environmental challenges facing Albertans and how law and policy can and should be brought to bear on these challenges.

One of the values that is nearest and dearest to the heart of the Centre is ensuring that members of the public—average Albertans—have an opportunity to become involved in and have an influence on the making and shaping of environmental law and policy. Only in this way can law and policy truly reflect the "public interest". In celebration of the Centre's 25th anniversary in 2007, the Centre is hosting a stakeholder round-table on how the concept of public interest informs environmental decision-making.

While all this has been going on, the Centre continued to carry out its core activities of public legal education, through answering inquiries from members of the public to making speeches and presentations to organizations around the Province, and law research and reform.

Every year is not without some regrets, and 2006 was no exception. Last year, the Centre said goodbye to its long-serving (18 years) librarian, Dolores Noga. She has been missed. Fortunately, the rest of the staff have continued their excellent work. In particular, the Directors would like to thank (again) the Centre's Executive Director, Cindy Chiasson, for her strong leadership.

Executive Director's Message

In 2006, the consistent element at the Centre was change. During the year, we made an office move to the Baker Centre in Edmonton and dealt with a number of staffing changes. While these administrative changes created some challenges, they also gave us the opportunity to look at our operations and activities through new eyes and from different perspectives. Changes in the federal and provincial governments and the upswing in public concern over environmental matters have increased the amount of government activity on the environmental regulatory and policy fronts. We have been involved in a steady surge of government consultations and initiatives on matters with major environmental implications, including oil sands development, water management, and land use policy.

2007 marks the Centre's 25th anniversary, a milestone for any charitable organization and particularly for one working on environmental issues in Alberta. A joint Board-staff strategic planning initiative that began late in 2006 will enhance our direction and focus, enabling us to make the most of our people and resources and to make a significant difference on Alberta's important environmental issues. We will also hearken back to our roots as a public interest organization, by carrying out a 25th anniversary research project examining and seeking to better define the public interest mandate of the Energy and Utilities Board and the Natural Resources Conservation Board.

2006 at the Centre

Highlights

In September 2006, the Centre debuted the Internet version of its library catalogue, allowing users to search and request library loans online. Earlier in the year, the Centre published two new law reform briefs, one focusing on public access to the Environmental Appeals Board process, and the second dealing with provincial and municipal regulation of brownfield redevelopment.

Public Programs

The public programs are the Environmental Law Centre's core activity. These include both ongoing activities and term projects, and encompass information services, monitoring and law reform, community services, publications and the public library of environmental law.

Information Services

This service, which is unique in Alberta, enables members of the public to contact the Centre and receive environmental law and policy information free of charge from a knowledgeable, independent source. As part of this service, the Centre maintains a lawyer referral list to assist staff in directing Centre users who seek legal representation. Lawyers who are interested in being included on this list are encouraged to contact Jodie Hierlmeier, Staff Counsel, (jhierlmeier@elc.ab.ca) for further information. In 2006, Centre staff answered 415 information requests and provided 96 referrals to lawyers.

Monitoring and Law Reform

Through these activities, staff pursue the Centre's mission of ensuring that laws, policies and legal processes protect the environment. Staff activities in this area include preparing reform briefs and commentaries, participating in law reform processes, and serving on law reform or monitoring committees.

In 2006, Centre staff provided briefs or comments on the following matters:

- South Saskatchewan River basin draft water management plan;
- Natural Resources Conservation Board draft compliance and enforcement policy:
- Bill 18 the Wilderness Areas, Ecological Reserves, Natural Areas and Heritage Rangelands Amendment Act, 2006;
- Energy and Utilities Board bulletin on commingling;
- Bill 29 the Environmental Protection and Enhancement Amendment Act, 2006;
- Submissions to the Oil Sands Panel on developing a framework for oil sands development in Alberta; and
- Comments on the statutory five-year review of the Canadian Environmental Protection Act, 1999.

The Centre also participated in a range of consultations during 2006, including:

- Legal rights to public notice and consultation before issuance of mineral dispositions;
- Municipal initiatives, including the City of Edmonton's draft Environmental Strategic Plan and development of an Edmonton-area land trust;
- Proposed provincial regulations, including remediation certificates, water diversion from coalbed methane wells, and regulations under the Agricultural Operation Practices Act;
- Provincial policy initiatives, including conservation easement strategy, water management, oil sands development, land use, and implementation of the Agricultural Operation Practices Act;
- Habitat protection and environmental assessment under the federal Fisheries Act, and
- Development of a western Canada water strategy.

Community Services

Greater understanding of environmental laws and policies helps citizens protect the environment. To add to this understanding, the Centre pursues opportunities to provide environmental law education services to various audiences. This includes providing assistance and information to community groups, environmental and industry organizations, and students through presentations, materials and the Centre's public library of environmental law.

In 2006, Centre staff made 25 presentations on the following topics:

- Land matters, including brownfield redevelopment, contaminated land, public lands and wildlife, planning, landfills regulation, conservation easements, and wetlands;
- Regulatory matters, including energy development, Alberta's environmental tribunals, and environmental legislation; and
- General environmental matters, including health and environmental law, environmental law services, and alternative legal careers.

Nearly 50% of these presentations took place in smaller Alberta communities. Centre staff also prepared two articles for outside publications, *Law Now* and *The Journal of Environmental Law and Practice*, and carried out a number of interviews with print and electronic media on a range of environmental topics.

In 2006, the Centre also supported the study of environmental law in Canada through its sponsorship of the 15th annual Sir John A. Mactaggart Essay Prize in Environmental Law. The essay competition is open to students studying in a recognized law program at a Canadian university and is sponsored by the Mactaggart Third Fund and Carswell. The 2006 first prize winner was Sarah Goard-Baker of the University of British Columbia for Canadian Federalism and the Environment: The Constitutional Confusion Around Treaty Implementation and Environmental Legislation, and the second prize winner was Burgandy Dunn of Queen's University for The Importance of Sustainable Environmental Development to International Peace and Security: The Repercussions of Water.





Publications

The Centre continues to provide access to environmental law and policy information through its publications. In 2006, the Centre published two briefs, *Brownfield Redevelopment in Alberta: Analysis and Recommended Reforms* by Jodie Hierlmeier, and *Public Access to Environmental Appeals: A Review and Assessment of Alberta's Environmental Appeals Board* by Cindy Chiasson and Jodie Hierlmeier.

The Centre continued to publish *News Brief*, its electronic newsletter that includes short articles and columns on environmental law and policy developments in Alberta and Canada.

Public Library of Environmental Law

The Centre's library is an important Canadian source of environmental and natural resources law and policy materials. The library is open to the public and loans materials free of charge to library users. The Centre's staff also assists library users in locating materials and carrying out their research. Over the course of 2006, the library collection grew to include over 22,500 records, including journals and periodicals, texts, decisions of courts and administrative tribunals, videotapes and legislation.

The Centre launched an Internet-searchable version of its library catalogue in September 2006. The web version enables Centre users to search the library catalogue and request materials via the Internet. Catalogued materials that are available elsewhere on the Centre's website are accessible through direct links from the catalogue.

Other Services

The Centre offers three services, consistent with its mission and ends, in addition to its public program activities. It offers two environmental information search services under agreements with Alberta Environment. These two services provide searches of databases for historical information in relation to environmental enforcement action and land reclamation regulatory actions taken by Alberta Environment. The net revenues from these search services are used to support the Centre's public programs and technology needs. The Centre's program staff also undertake fee for service work consistent with the Centre's mandate.





Community Contributions

Based on their environmental law experience and expertise, Centre program staff are often asked to provide input on environmental law and policy and participate in related initiatives. In 2006, Centre program staff were involved on these boards, committees and groups:








2006 Sources of Support (Revenues)

About the ELC

The Environmental Law Centre (Alberta) Society* is a registered charity that was incorporated in Alberta in 1982 to operate the Environmental Law Centre. The Centre's purpose is to provide Albertans with an objective source of information about environmental and natural resources law. Its vision is a clean, healthy and diverse environment protected through informed citizen participation and sound law and policy, effectively applied.

The Centre's mission is to ensure that laws, policies and legal processes protect the environment. In pursuit of this mission, the Centre seeks the following ends: enactment and effective enforcement of sound environmental laws and policies; and effective and informed public participation in environmental regulatory, law-making and decision-making processes.

The Centre carries out activities in three main program areas: public programs, fee for service and search services. The net revenue from the latter two programs is applied to support the Centre's public programs and technology needs.

Staff members undertake program delivery with assistance from contractors and volunteers, as necessary. A volunteer Board of Directors oversees Centre operations. Members of the Board represent a full range of interests in environmental law in Alberta including law, business, industry, environmental organizations and the general public.
